- The Supplemental Property is hereby Annexation of Supplemental Property. annexed into the Declaration and all terms, conditions, covenants and restrictions of the Declaration shall be applicable to the Supplemental Property, including, but not limited to the obligation to pay dues, charges and assessments to the Association that are required to maintain common areas, entry features, landscaping within the Property or future Property to be annexed with the Property.
- No Further Changes. Except as expressly set forth herein, the Declaration shall remain unchanged and shall continue in full force and effect.


